The result analysis of MAY 2018, VIII, VI, IV & II semester Deemed University batch is enclosed. It was observed that the results of VIII semester are satisfactory. The results of II, IV & VI semester Deemed University batch are comparatively better than VTU results. However, there is scope for improvement in the context of Deemed University Status.	Members suggested improving the result further by conducting extra/special classes for the weaker students, after indentifying them in the middle of the semester itself, in view of getting University status.
3. Reporting on the placement activities in the campus.	Placement Activity for the 2018 batch (student list is enclosed) A total of 140/230 eligible students are placed in various companies there is decrease in the recruitment compare to last year, This is because of our students has to compete with all the other graduated students	The members appreciated the effort of placement department and suggested to conduct more personality development and communication skill programs for the students.
4. Reporting on the approval of the Budget for the year 2018-19.	The copy of the budget for the year 2018-19 is enclosed. The income for the 2018-19 is 3,418 lakhs. A deficit of Rs.300 lakhs is supposed to be made good by the society (SSES).	Budget was approved and the members appreciated the society for the generosity in the development of Institution.
5. Reporting on other matters that are discussed.	Dr.M.Siddappa ,HOD CSE has been given an additional charge of Dean Academic after the Superannuation of Dr.Rajesh Kamath of EEE branch. Permission has been given from AICTE for the Increase of Intake in CVE & EEE branches from 60 to 120 and admissions are going are for the academic year 2018-19. As per the guide lines from UGC/AICTE from the academic year 2018-19 the number of credits to get the degree has been fixed by the CDC(Curriculum Development Committee), BOS and Academic Committee has (i) UG-170 credit (ii) PG-88 credits (iii) MCA-123 credits. Accordingly the syllabus and curriculum has been changed from this academic year 2018-19.
